### **LSB investigation – Revised timetable**

1. Following my letter of 11 October 2022 which set out the terms of engagement and scope of the investigation and subsequent communication, I am writing to now formally notify you of a revision to the timetable.
2. We noted that the timetable would be kept under review as the investigation progressed and may be altered or extended where appropriate. As a result of the later submission of representations and the need for a further information request, we require additional time to fully consider the additional information. The consequence of that is that we do not expect to be in a position to share our draft findings report with you until 1 March 2023. I have provided a revised timetable at the Annex – this updates the timetable Annexed to my letter of 11 October 2022 - for your information with the revised timings highlighted and completed actions greyed-out.
3. A revised operational plan with the revised timings is also annexed and will not be published. We draw your attention to Step 7 of that plan: CRL and CILEX will have a two-week period to review and comment on the draft report before it is finalised.
4. Whilst we understand that it is in all parties' interests for the investigation to proceed in a timely manner, it is important to ensure that we have properly considered all the relevant information and documents provided.
5. I have written in similar terms to Carilyn Burman, CEO of CILEx Regulation and copied to Russell Cooke. We will publish this letter on our website alongside previous correspondence.
